Pre-requisite qualification for purchase of Bid Documents:

- (i) Minimum Average Annual Turnover (MAAT) for the best three years of last five financial years of the bidder should not be less than 30% of the estimated cost put to the tender i.e. Rs. 150.65 Lakhs for "A", Rs. 97.50 Lakhs for "B" and Rs, 88.00 Lakhs for "C".
- (ii) Liquidated Assets @10% of estimated cost put to tender i.e. Rs. 50.22 Lakhs for "A", Rs. 32.50 Lakhs for "B" and Rs, 29.33 Lakhs for "C". *(In case a bidder is quoting for more than one project, Pre-Qualification requirement shall be examined on the basis of sum of project wise requirements of LA of all quoted projects).*
- (iii) The bidder must have experience certificate from any utility like PGCIL/State Power of having successfully designed, constructed, manufactured, type tested and erected similar nature of works during last 7 (seven) years as on the date of bid opening which must be in satisfactory operation for at least 2(two) years as on date of bid opening. Such certificate should be signed not below the rank of Executive Engineer.
- (iv) No Due Certificate/NOC from the Arunachal Pradesh State Apex Bank Limited, Naharlagun issued by the Managing Director to be produced along with attested copy of Valid GST, PAN Card and Income tax clearance certificate from the competent authority.

- (v) The application for issue of Tender Documents for the prospective bidders qualifying above criteria shall be received untill 29th December 2017

The prospective bidders who qualify the above mentioned pre-requisite qualification criteria set forth, may apply for purchase of the tender documents with the supporting documents as stated above, from the office of the **Executive Engineer (E), Rumgong Electrical Division, Rumgong** on any working days as mentioned above with non refundable fee of **Rs. 25, 000.00** (Rupees Twenty Five Thousand) only in the form of demand draft of any scheduled bank payable at **State Bank of India, Aalo**; in favour of the **Executive Engineer (E), Rumgong Electrical Division, Rumgong**.
