
Three claims and objections were received viz. from Shri Ogum Moyong, Shri B.S.Kaneri and Shri Bar Takum, SEs.

As per the claim raised by Shri B.S.Kaneri, he is supposed to be the senior to Shri Rokam Bado in the rank of Executive Engineer. This has been found correct. Hence his seniority has been restored above Shri Rokam Bado, in the rank of Executive Engineer.

Shri Bar Takum's claim was to the effect that his service as SE was regularized w.e.f. 21/3/2007. This has been found correct. Hence this has been corrected as 21/3/2007.

The final seniority list of SE (Elect) is accordingly published as annexed hereto.




