The Governor of Arunachal Pradesh is pleased to order the revocation of earlier Govt. Order No. PWRS/W-46/95-96/2075-82, dtd. 05/02/1996, and restore with immediate effect, all the normal enhanced financial powers delegated to Executive Engineers of works department under the Govt. of Arunachal Pradesh to the Executive Engineers of Department of Power /Hydro Power Development with regards to award of work orders as per CPWD Manual Vol-II, and such Memoranda issued by the CPWD authorities from time to time.

The Executive Engineers under Deptt. of Power/Deptt. of Hydro Power Development are allowed to exercise above delegated power with immediate effect subject to fulfillment of all other requisite conditions laid down in the relevant CPWD Manual Vol.II, such as adherence to annual limit of amount and budgetary coverage, statutory sanctions of the competent authority before issue of such work orders against any work.
