8. Appropriation and Re-appropriation of budget.
9. Work related loans and advances.
10. Monitoring and evaluation of projects.
11. Preparations of Schedule of rates and cost index.
12. Contractor Licensing/registration and revalidation.
13. Preparation of Annual Operation Plan.
14. Enactment of Electricity Act.
15. Quality control.

It is also further ordered in public interest, that the following officers of the Department of Power are transferred to the administrative jurisdiction of the CE (P&M) with immediate effect.

3. Smti. M. Jini, ASW from the office of the CE, WEZ.


