**ORDER**

In the interest of public service the Governor of Arunachal Pradesh is pleased to order reorganisation of the Department of Power as under :-

Consequent upon the reorganisation of the Power Department as above, the Governor of Arunachal Pradesh is pleased to further order as under :-

1. Er. Takar Mara, Adviser(Power), is posted as the Chief Engineer(Power) Central Electrical Zone. He will however, continue to discharge the responsibilities of Adviser(Power) till further order.
2. All the Divisions and Sub-Division with men and materials under administrative and technical control of concerned Electrical Circles will automatically come under the control of respective Zones.
