Pre-requisite qualification for purchase of Bid Documents:

- (i) The bidder should possess minimum **SEC-C Class License** issued by the Chief Engineer (Power), TP & M Zone, Deptt. Of Power, Aruanchal Pradesh or "**B or II**" Class license issued by the Central Inspectorial organization of Govt. of India/ Other State Government. In case of joint venture firm, any of the partners should possess minimum qualification stated above.
- (ii) Minimum Average Annual Turnover (MAAT) for the best three years of last five financial years of the bidder should not be less than 30% of the estimated cost put to the tender i.e. **Rs. 106.64 Lakhs**
- (iii) Liquidated Assets @10% of estimated cost put to tender i.e. **Rs. 35.55 Lakhs**
- (iv) The bidder must have experience certificate from any utility like PGCIL/State Power of having successfully designed, constructed, manufactured, type tested and erected similar nature of works during last 7 (seven) years as on the date of bid opening which must be in satisfactory operation for at least 2(two) years as on date of bid opening. Such certificate should be signed not below the rank of Executive Engineer.
- (v) No Due Certificate/NOC from the Arunachal Pradesh State Apex Bank Limited, Naharlagun issued by the Managing Director to be produced along with attested copy of Valid GST, PAN Card and Income tax clearance certificate from the competent authority.
- (vi) **The application for issue of Tender Documents for the prospective bidders qualifying above criteria shall be received untill 17th February 2019**
