Application for purchase of tender document must accompany the following:

1. A valid (original) Electrical License/Registration Paper confirming the eligibility of the firm.
2. Prospective bidder(s) shall have to furnished the following in original :
 - i. GST Registration Certificate, PAN Card and Trading License.
 - ii. Latest Income Tax Clearance Certificate from the competent authority and GST Clearance Certificate in Form GSTR-3B.
 - iii. Documentary evidence in support of their executing similar nature of work with equivalent amount in a Single Order in the last three years which commensurate to tender package being purchased.
 - iv. The intending Bidder should append with their application the details and expertise for issue of tender papers. The tender papers shall be issued only after ascertaining about the Bidders' expertise and experience in the similar works or any other allied works.
 - v. The bidders must have experience certificate against the work as indicated in the table under any Utility like Department of Power, Govt. of Arunachal Pradesh, Telecommunication, Railways, PGCIL, NTPC, NEEPCO, MES, other State Power Utility, having successfully completed and commissioned such nature of works or allied works as on date of bid opening, and which must be in satisfactory operation for at least

2(Two) years as on the date of bid opening. Such certificate should be signed by not below the rank of Executive Engineer. Such authentic proof of documents like Award Letter and successful completion certificate of owner must be enclosed. Preference will be given to Bidder (s) who have executed similar works or allied works in the state of Arunachal Pradesh during the last 5 (five) years.

- vi. Preference shall be given to eligible classes as specified under Arunachal Pradesh District Based Entrepreneurs & Professionals (Incentives, Development and Promotional) Act 2015, provided that all other necessary qualifying requirements are fulfilled.
- vii. The contractor shall have to make a declaration to be executed in affidavit that he is not engaged in more than two tender works under the state government as per APDBE&P Act 2015.
- viii. The application for bid document accompanied with cost of bid document in cash or demand draft payable at SBI, Pasighat along with a copy of the above supporting documents has to be addressed and submitted to the below mentioned address :

- viii The bid documents shall neither be sold nor accepted for opening through postal or courier service.
 - ix. The Department of Power shall not be responsible for any form of delay in receiving the bid document.
3. Prospective Bidder (s) shall have to submit all of the qualifying requirements as appended from SI. No. 1 through 2 (viii) along with the bid documents failing which their bid shall be liable for rejection.
