
1. A valid (Original) Electrical license/Registration paper confirming the eligibility of the firm.

4. Proof of PRC/domicile certificate, AADHAR card and Voter ID card issued by CEC/GOI as proof of address.

Preference shall be given to eligibility class as specified under Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentives, Development and Promotional) Act 2015 as per guidelines issued by the Government of Arunachal Pradesh Notification dtd 13<sup>th</sup> April 2015 subjected to fulfillment of condition of above Sl No. 1, 2, 3 & 4.
