VACANCY CIRCULAR

Applications are invited in the proforma enclosed in the annexure from Indian citizens having qualification and experience as mentioned below for appointment as Member(Law) of Arunachal Pradesh State Electricity Regulatory Commission(APSERC), so as to reach the **Under Secretary(Power), Government of Arunachal Pradesh, AP Civil Secretariat, Block No. 3, Room No. 1, 5th floor, Itanagar latest by 4.00 PM on 29 July 2022.**

APSERC was constituted as a single member Commission under the provision of Electricity Act 2003 on 7th May 2010. An additional post of Member was created on 24th March 2022. Now the APSERC will consist of a Chairperson and a Member(Law).


The Hon'ble Supreme Court on 12th April 2018 pronounced a judgement in the Civil Appeal No. 14697 of 2015- State of Gujrat &Others vs Utility Users' Welfare Association &Others. As per this judgement of the Hon'ble Supreme Court, it is mandatory that there should be a person of law as a Member of the Commission, which requires a person, who is, or has been holding a judicial office or is a person possessing professional qualifications with substantial experience in the practice of law, **who has the requisite qualifications to have been appointed as a Judge of the High Court or a District Judge.**

Section 84(1) of the Electricity Act, 2003 states that the Chairperson and the Members of the State Commission shall be persons of ability, integrity and standing who have adequate knowledge of, and have shown capacity in, dealing with problems relating to engineering, finance, commerce, economics, **law** or management. This vacancy circular is to fill up the newly created Member from the **field of law** as per above Supreme Court judgement and as per provision of section 84(1) of the Electricity Act, 2003.

Term of office and conditions of service of Member shall be governed by provisions in Section 89 and any other relevant provisions of The Electricity Act, 2003.

The Member shall receive salary in Pay Matrix Level 15 in the Pay Band of Rs 67000-Rs 79000/- per month and other allowance admissible to post in state belonging to All India Service Cadre.
