

No tender paper shall be sold to any

intending bidder(s) unless application for such is accompanied by these above documents. The Arunachal Pradesh District Based Entrepreneurs and Professional (Incentives, Development and Promotional) Act,2015 shall be enforced.
Department of Power reserves all the right to cancel/withdraw the bid in full or part without assigning any reason for such decision and to place order in full or in part. Such decision will not incur any liability whatsoever on the part of Department of Power consequently.


