### NOTICE INVITING TENDER

1. The Executive Engineer (Elect.), Basar Electrical Division, Department of Power, Basar on behalf of Governor of Arunachal Pradesh invites the item rate tenders from registered and eligible/experienced firm for execution of following work.

2. The contractor who fulfil the following requirements shall be eligible to apply. Preference will be given to local electrical registered contractors of domiciled within territorial jurisdiction of **Basar Circle, 29<sup>th</sup> Basar Assembly Constituency** as per Arunachal Pradesh District Based Entrepreneurs and Professionals (INCENTIVE, DEVELOPMENT AND PROMOTIONAL) ACT, 2015. However, in case of non-availability of registered contractor in the 29<sup>th</sup> Basar Assembly Constituency then Electrical registered contractors from 28<sup>th</sup> Likabhali (ST) Assembly constituency, 27<sup>th</sup> Liromoba (ST) AC, 31<sup>st</sup> Aalo East & 30<sup>th</sup> West (ST) AC shall be given preference.

a) Should have satisfactorily completed the works as mentioned below during the last five years ending previous day of last date of submission of tenders.

(i) Three similar works of each value not less than **Rs 40.08 Lakh** or two similar works of each value not less than **Rs 60.12 Lakh** or one similar work not less than **Rs 80.16 Lakh** in aggregate during the last 5 (five) years.

For the purpose of the clause similar works means the work of **“Internal / External Wiring”**

The value of executed works shall be brought to current costing level by enhancing the actual value of works at simple rate of 7% per annum; Calculated from the date of completion to last date of receipt of applications for tenders.

b) Should have had average annual financial turnover of **Rs 75.15 Lakh** on construction works during the last best three years out of five years ending 31<sup>st</sup> March 2026.

c) Should not have incurred any loss in more than two years during the last five years ending 31<sup>st</sup> March 2026.

d) Should have a Solvency of **Rs 10.02 Lakh**.

- 3 Bid documents consisting of plans, specifications, the schedule of quantities of the various types of work to be done and the set of terms and conditions of contract to be complied with the contractor whose bid may be accepted and other necessary documents can be seen in the office of the Executive Engineer (E), Basar Electrical Division, Department of Power, Basar between hours of 10.00AM and 4.00PM from **23/04/2026 to 30/04/2026** every day except on Sunday and public holidays. Bid documents, including standard form will be issued from this office during the hours specified above, on payment of **Rs 4000/-** as cost of bid documents.

4 Applicant has to deposit earnest money **Rs 1,00,198/-** (APST firm) in the form of fixed deposit receipt of a schedule bank / demand draft of a scheduled bank issued in favour of **Executive Engineer (E), Basar Electrical Division, Department of Power, Basar** along with tender documents.

5 Application supported by prescribed annexure and the financial bid shall be placed in separate sealed envelopes each marked **“Technical Bid”** and **“Price Bid”** respectively. Both the envelopes shall be submitted together in another sealed envelopes. The bid will be received upto **12.30 PM** on

6 Application for purchase of tender document must accompany the following documents:-

- i. A valid contractor registration certificate of **Class – B / C ( Supply&Erection )** issued by the Department of Power, Govt. of Arunachal Pradesh & PRC // Aadhar Card // Voter ID of contractor for proof of domicile.
- ii. GST registration Certificate, PAN Card and Trading License.
- iii. Latest Income Tax Clearance Certificate and GST Clearance Certificate (**GSTR-3B**).
- iv. Documentary evidence in support of executing similar nature of work with equivalent amount in single order in last three years which commensurate to tender being purchased.
- v. Experience certificate from any utilities like DoP, APPWD, RWD, DHPD, PHED, PGCIL, Railways, NEEPCO, BSNL and MES having successfully constructed similar nature of works during the last 3 (Three) years as on the date of bid opening which must be in satisfactory operation for at least 2(two) years as on date of bid opening. Such certificate should be signed not below the rank of Executive Engineer. Preference will be given to contractors who have executed similar nature of work in Arunachal Pradesh.
- vi. An affidavit regarding declaration that the bidder is not engaged in more than 3 (three) any tender works under state govt. during current financial year.
- vii. No Due Certificate from the Arunachal Pradesh State Apex Bank Limited, Naharlagun, issued by the Managing Director Cum Chief Executive Officer.

4 The tender paper shall neither be sold nor be accepted for opening through postal or courier services.

5 The Department shall not take responsibility for any form of delay in receiving the tender papers in time and no extension of time shall be entertained on such account. Tender papers received after due date or time of submission will not be accepted under any circumstances.

6 Pre-Bid conference shall be held in the Office of the Executive Engineer (Elect.), Basar Electrical Division, Department of Power, Basar at **10.30 AM on 02/ 05/2026** to clear the doubt of intending tenderers, if any.

7 The Department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
