



1. The Sale by quotation will be "As is where is basis". The bidder shall quote the maximum amount offered in figure for the items mentioned above. The bidder should submit the bidding documents/quotations in seal enveloped in favour of Executive Engineer (E), Miao Electrical Division, Department of Power, Miao on or before 20th November 2025 upto 11.00 HRS.
2. The quotations/bid documents shall be open on 20th November 2025 at 1500 HRS by a board of members. The interested bidder may present at the time of opening of the quotation in the office chamber of Executive Engineer (E), Miao Electrical Division, Department of Power, Miao.
3. Prospective Bidder should posses and submit a valid Trading License dealing with scrap materials and having GST registration alongwith bidding documents.
4. The intending bidders should submit site visit certificate alongwith photographs.
5. The successful bidder should deposit SD not less than 25 (Twenty Five) per cent of the bid value in cash on the spot and deposit the balance bid amount/ purchase amount in full within 7 (Seven) days after the acceptance of the offer and lifting shall have to be started within 3 (Three) days from the date of deposit of bid money, failing which the deposited earnest money will be forfeited to the Government.



6. Every quotation must clearly mention the amount offered (both in figures and in words) alongwith and Earnest Money deposit (EMD) of the above materials. The Earnest Money shall be deposited in Demand Draft of any nationalized bank in favour of Executive Engineer (E), Miao Electrical Division, Department of Power, Miao payable at SBI Miao. The earnest money will be refunded to the unsuccessful tenderer/bidder.


