5. The bidder must have had average annual financial turnover of at least 50% of the estimated cost put to tender during the immediate last 3 consecutive financial ending 31st March 2023 certified by the Chartered Accountant.

6. The bidder must have a solvency of the amount equal to 40% of the estimated cost put to tender from any Scheduled Bank.


