NOTICE INVITING TENDER (NIT)

The Executive Engineer (E), Pasighat Electrical Division, Department of Power, Pasighat, on behalf of the Governor of Arunachal Pradesh, invites sealed item rate tender in PWD Form-8 from the registered and eligible / experienced contractors / Firms registered in appropriate classes having electrical license issued from electrical licensing authority/board and as per the Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentives, Development and Promotional) Act 2015 / Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentives, Development and Promotional (Amendment Act 2020) for the work as per details stated below:

Application for purchase of tender document must accompany the following:

1.
 - i. A valid Certificate (original) of **Supply & Erection Contractor (SEC) Class C** enlisted with the Department of Power, Govt. of Arunachal Pradesh/Registration Paper confirming the eligibility of the firm. As per the Under Secretary (Power & NEC), Govt. of Arunachal Pradesh, Itanagar Memo No. Power-12020/10/25(250382)/5137-40, Dated, 20.06.2025, Electrical License Holders of all categories from the neighboring states are not eligible for bidding.
 - ii. GST Registration Certificate, PAN Card, Trading License, PRC / Domicile Certificate, Voter ID, etc.
 - iii. Latest Income Tax Clearance Certificate from the competent authority and GST Clearance Certificate in Form GSTR-3B.
 - iv. The prospective Bidder should append with their application the details and expertise for issue of tender papers. The tender papers shall be issued only after ascertaining about the Bidders' expertise and experience in similar works or any other allied works.
2. In addition to the above (mentioned at Sl. No. 1), a prospective bidder(s) shall have to furnish the following eligibility Documents to be furnished along with the bid document:
 - i. Documentary evidence in support of their executing similar works with equivalent to 40% of the tendered amount in a Single Order/Multiple orders in the last five years which is commensurate to the purchase of the tender package.

- ii. The bidders must have experience certificates against the work/allied work as indicated in the table under any Utility like Department of Power, Govt. of Arunachal Pradesh, Railways, PGCIL, NTPC, NEEPCO, MES, other State Power Utility, having successfully completed and commissioned similar nature of works or allied works as on date of bid opening, and which must be in satisfactory operation for at least 2 (Two) years as on the date of bid opening. **Such certificate should be signed by not below the rank of Executive Engineer.** Such authentic proof of documents like Award Letter, Work Orders and successful completion certificate of the owner must be enclosed. **Preference will be given to Bidder (s) who have executed similar works or allied works in the state of Arunachal Pradesh during the last 5 (five) years.**
- iii. The Bidders submitting experience certificates of the works executed through sub-let/sub-contract works shall not be eligible to participate or qualify in the bid.
- iv. The bidding contractors shall have to make a declaration to be executed in an affidavit that he is not engaged in more than three tender works under the state government.
- v. The bidding contractors shall have to make a declaration to be executed in an affidavit that there are no ongoing litigations against their firm.
- vi. The bidding contractors shall have to make a declaration to be executed in an affidavit that no near relatives in any capacity are working in the Department of Power, Govt. A.P
- vii. The bidding contractors shall have to submit NOC from the Arunachal Pradesh APEX Bank and No Criminal Certificate from competent authority.
- viii. In addition to the execution of similar nature of work(s)/allied work(s), preference will also be given to all the registered contractors in classes categories mentioned above domiciled within the territorial jurisdiction of Assembly Constituency, as per ((APDBE & P(IDP) Act 2015)) Arunachal Pradesh District Based Entrepreneurs and Professional (Incentives, Development and Promotional) Act 2015 and its subsequent amendments.
- ix. The application for bid documents accompanied with the cost of bid documents in cash or demand draft payable at SBI, Pasighat along with a copy of the above-supporting documents (mentioned at Sl. No. 1 (i) to (viii)), has to be addressed and submitted to the below-mentioned address:

- vii. The bid documents shall neither be sold nor accepted for opening through postal or courier service.
- viii. The Department of Power shall not be responsible for any form of delay in receiving the bid document.

3. The Executive Engineer (E), PED, DOP, Pasighat reserves all the rights to accept or reject any / all tenders or to annul the process without assigning any reason, whatsoever.

4. **Prospective Bidder (s) shall have to submit all of the qualifying requirements as appended from Sl. No. 1 through 2 (viii), along with the bid documents failing which their bid shall be liable for rejection.**
