## NOTICE INVITING TENDER

### Invitation for Bid (Modified as per OM/MAN/160 & 221)

- 1) On behalf of the Governor of Arunachal Pradesh **Sealed Item Rate Tender** in **C.P.W.D form – 6 & 8** are invited from the eligible and experienced firms / contractors as per the qualifying criteria specified in the detailed N.I.T for turnkey execution of **specialised electrical work** as mentioned below:-

- 2) Contractors who fulfil the following requirements shall be eligible to apply. Preference will be given to local electrical registered contractors domiciled within **54 - Namsang-Deomali Assembly Constituency** as per the provisions of the **Arunachal Pradesh District Based Entrepreneur and Professionals (Incentives, Development and Promotion) Act, 2015**, with its latest amendments. However, if no applications are received from any eligible contractors domiciled within territorial jurisdiction of above assembly constituency up to **4.00 P.M** on **07.03.2024**, the tender shall be **opened to all** experienced firms / contractors operating in Arunachal Pradesh subject to fulfilment of eligibility criteria. Applications from such intending bidder(s) shall be received from **08.03.2024** to **11.03.2024** except Sundays and public holidays.

- a) Should have satisfactorily completed the similar nature works of magnitude specified below during the last three years ending previous day of last date of submission of tenders: -

Three similar works of each value not less than **Rs.137.30 Lakhs** or two similar works of each value not less than **Rs.205.96 Lakhs** or one similar work of value not less than **Rs. 274.61 Lakhs** in aggregate during the last 3 (Three) years and which must be in operation for at least 2 (two) years as on date of opening of bid.

For the purpose of the clause similar works means the works of “**Overhauling, repair, and overhauling of 132/33kV or above Power Transformer or Power Transformer winding replacement works for 132/33kV & above or Power Transformer OEM authorised Vendor for 132/33kV & above and such repairing and overhauling having mandatory testing jobs, dismantling and re-tanking jobs of Power Transformer**”.

**Preference will be given to firms / contractor who have successfully executed similar nature of works in Arunachal Pradesh.**

- b) Should have had Average Annual Financial Turnover of **Rs.343.26 Lakhs** during the last best three years out of five years ending 31<sup>st</sup> March 2023.
- c) Should have a solvency of **Rs. 137.30 Lakhs**.
- 3) Bid documents consisting of plans, specifications, the schedule of quantities of the various types of work to be done and the set of terms and conditions of contract to be complied with the contractor whose bid may be accepted and other necessary documents can be seen in the office of the **Executive Engineer (E), Transmission Division No. III, Department of Power, Pasighat** between hours of **10.00 AM** and **4.00 PM** from **29.02.2024** to **11.03.2024** every day except on Sunday and Public Holidays. Bid documents, including standard form will be issued from this office, during the hours specified above, on payment **₹5,900/-** in cash / Demand Draft as cost of bid document.
- 4) Applicant has to deposit Earnest Money of **Rs. 3,43,260/-** (APST firm) / **Rs.6,86,520/-** (Non-APST Firm) in the form of **Terms Deposit Receipt / Fixed Deposit** of a schedule bank (Must be valid for a period not less than 6 months) issued in favour of the **Executive Engineer (E), Transmission Division No. III, Department of Power, Pasighat** along with tender document.
- 5) Application supported by prescribed annexure and the financial bid shall be placed in separate sealed envelopes each marked "**Eligibility Documents**" and "**Price Bid**" respectively. Both the envelopes shall be submitted together in another sealed envelope. The bids will be received **up to 11.00 A.M on 13.03.2024**. The envelopes Marked "**EMD**" shall be opened first and "**Price Bid**" by the Executive Engineer or his authorized representative in his office on the same day at **11.30 A.M**.
- 6) Tender paper will be issued to prospective bidders provided they produce the following documents: -
  - i) Copy of a valid **Contractor Enlistment Order of Class - C (Supply & Erection)** issued by Department of Power, Govt. of Arunachal Pradesh / **Valid Electrical License of Class - II** issued by competent authority issued by the competent authority.
  - ii) Experience certificate having successfully completed similar nature of work during last 3 (three) years as on the date of bid opening. **Such certificate should be signed not below the rank of Executive Engineer.**
  - iii) Copy of Valid GST Registration Certificate and latest GSTR 3B.
  - iv) Copy of PAN Card & Latest Income Tax Clearance Certificate from the competent authority.
  - v) Copy of PRC / Domicile Certificate / Voter ID / Aadhar Card issued by competent authority.
  - vi) Copy of No Due Certificate from the Arunachal Pradesh State Apex Bank Limited, Naharlagun, issued by the Managing Director-Cum-Chief Executive Officer.
  - vii) The prospective bidder shall have to make a declaration to be executed in an affidavit duly attested by Executive Magistrate / Notary that **he / she is not engaged in three or more tender works under the State Government.**
- 7) Pre-Bid conference shall be held in the Office of the **Executive Engineer (E), Transmission Division No. III, Department of Power, Pasighat** at **11.30 A.M on 11.03.2024** to clear the doubt of intending tenderers, if any.

- 8) The Department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
