The Executive Engineer (Elect.), Rumgong Electrical Division, Department of Power, Rumgong on behalf of the Governor of Arunachal Pradesh invites sealed item rate tender from approved and eligible contractors of State DoP/PWD/RWD/PHED/DHPD dealing with building and roads, domiciled within the territorial jurisdiction of 32-Rumgong (ST) AC in one envelope system for the following work on turnkey basis:-

- Last Date & Time for Bid submission shall be **22/11/2024 from 9300 Hrs to 1100 Hrs** on the same day.
- Date & Time of Bid Opening shall be on **22/11/2024 at 1130 Hrs.**

The Tender Paper can be obtained from the office of the Executive Engineer (E), Rumgong Electrical Division, Department of Power, Rumgong; with non-refundable fee of Rs. 5,000.00 (Rupees Five Thousand) only per Bid Documents, in Cash.

- The Arunachal Pradesh District Based Entrepreneurs and Professionals (INCENTIVE, DEVELOPMENT AND PROMOTIONAL) ACT, 2015 shall be applicable.
- Criteria for eligibility for issue of tender documents: -

- 3.1 All registered contractor in **Class-III & II (Civil) Category** duly registered under Arunachal Pradesh Contractor Enlistment Rules-2008, domiciled within the territorial jurisdiction of **32-Rumgong (ST) A/C**, and other criteria as notified in Arunachal Pradesh District based entrepreneurs and professionals (incentive, development and promotional) Act 2015 vide No. SPWD/W-66/2012/314 Dtd. Itanagar the 13th August 2015 are eligible to participate in the tendering process
- 3.2 Tender documents will be issued to eligible registered contractors provided they produce proof of registration / enlistment from the competent authority, which shall be to the satisfaction of competent authority.
- 3.3 Experience certificate having successfully constructed similar nature of works during the last 7(seven) years as on the date of bid opening which must be in satisfactory operation for at least 2(two) years as on date of bid opening. Such certificate should be signed not below the rank of Executive Engineer.
- 3.4 Copy of Valid GST Registration, Last quarter GSTR-3B clearance, PAN Card and Latest Income Tax Clearance Certificate from the competent authority.
- 3.5 No Due Certificate from the Arunachal Pradesh State Apex Bank Limited, Naharlagun, issued by the Managing Director Cum Chief Executive Officer.
- 3.6 Permanent Residential Certificate, Aadhar Card, Voter ID card issued by the competent authority to be submitted as proof of being the domicile within the territorial jurisdiction of **Assembly Constituency** to participate in the tender in persuance to the **Arunachal Pradesh District Based Entrepreneurs and Professionals (INCENTIVE, DEVELOPMENT AND PROMOTIONAL) ACT, 2015.**
4. The intending tenderer shall have to apply for the tender document in Contractor's / Company's printed letter pad with detail postal address, Telephone, Mobile & Fax and E-mail ID, etc.
5. The tender paper shall neither be sold nor be accepted for opening through postal or courier services.
6. The Department shall not take responsibility for any form of delay in receiving the tender papers in time and no extension of time shall be entertained on such account. Tender papers received after due date or time of submission will not be accepted under any circumstances.
7. Pre-Bid conference shall be held in the Office of the Executive Engineer (Elect.), Rumgong Electrical Division, Department of Power, Rumgong at **11.00 AM** on **20.11.2024** to clear the doubt of intending tenderers, if any.



8. The Department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
